### RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

1. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE THE LEO GOLF ACADEMY, their officers, employees, board, and agents (hereinafter referred to as "releasees") from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, while the undersigned participates in the training programs organized by the LEO GOLF ACADEMY.

The undersigned is aware of the risk that any part of his/her body or any of his/her body systems may be hurt or injured by participation in the training programs.
